#### **SNOWPLOW REMINDER**

County Public Works asks residents who plow the snow in their driveway entrances to have snow moved well into the right hand corner of the entrance ditch.

This improves the ability of our grader operators, who are plowing County roads, to minimize the amount of snow left behind at driveway entrances.

In addition, residents are asked to not leave ridges of snow on the County roads.



## SNOW CLEARING OF PRIVATE DRIVEWAYS (County Policy No. 03-35)



Public Works Dept. would like to remind all residents who have purchased a flag that Snow will be cleared along the most direct route commonly used to access the residence, including the turn-around in the yard where it is safe to do so, conditional upon a minimum of 6 inches of snow.

#### COUNTY FIRE PERMITS ARE REQUIRED ALL YEAR

Although it's winter, a fire permit is required at all times (including for the lighting of fireworks).

Appropriate county staff may extend the period of time that a Fire Permit is valid, provided the Fire Permit has not expired.

Request for Fire Permits must be made in person at the County Office with the appropriate county staff. No fee is charged for fire permits but there is a \$300 fine if there is burning without a permit, plus the cost of any fire fighting if a fire burns out of control. A Fire Permit is not transferable.
