Policy Statement No. 03-25-10: Sale of Gravel or Sand - <u>Purpose:</u> To provide a guideline and protocol for the sale of Municipal Gravel or Sand (aggregate) Material.

The County retains aggregate material for the purpose of supporting road construction or maintenance activities and will provide the opportunity, as a service to its residents, to sell gravel or sand material within the boundaries of Smoky Lake County to its' residents.

REOPENING TO THE PUBLIC

Smoky Lake County will be reopening the Main Office and Public Works Shop Office to the Public, effective **Tuesday**, **August 4**, **2020 How We Are Keeping Everyone Safe:**

BEAVER MANAGEMENT PROGRAM

Smoky Lake County will pay \$15.00 for each beaver removed in problem areas to the trapper or landowner as per Policy Statement No. 07-06.

- The Agricultural Fieldman or Assistant Agricultural Fieldman must complete an inspection prior to beaver removal to confirm the problem area is affecting agricultural land or County infrastructure to qualify.
- Proof of beaver removal is accepted by Appointment Only at the County office.

DECLARATION OF MUNICIPAL AGRICULTURAL DISASTER

On June 25th, 2020 Smoky Lake County Council declared a Municipal Agricultural Disaster for Smoky Lake County. This declaration was made to call the attention of Provincial and Federal levels of Government regarding the financial strain that is burdening the agricultural community due the severe moisture conditions seen throughout the County, which is causing unseeded acres, inability to complete the 2019 harvest, loss of seeded acres, and flooded pastureland and hay crops. Municipal declarations do not automatically trigger access to provincial or federal funding, only Provincial declarations do, and Smoky Lake County Council will continue to advocate on behalf of its producers to bring awareness to the Province.
