The Reeve Dareld Cholak called the Public Hearing to Order at 9:15 a.m. in the presence of all the Council members, the Chief Administrative Officer, Assistant Chief Administrative Officer/ Recording Secretary, and Finance Manager.

Public Hearing:

Bylaw No. 1216-10:

Develop and adopt a Mons Lake Area Structure Plan.

General public: 18 members of the public in attendance for the Public Hearing.

Responses

The Reeve reported that no verbal response or written response had been received to the proposed Bylaw.

Bylaw 1216-10: was given first given first reading on December 17, 2010 to authorize Smoky Lake County to develop and adopt a Mons Lake Area Structure Plan.

General Public

Against the Bylaw(s):

Comments for Clarification:

- Sub-dividing land around the lake? Allowing lots more than 2 acre to be sub-divided.

Planning Manager - Reply: Any area around the lake is still subject to the rules in the Land Use Bylaw and Municipal Development Plan. No further restrictions would be place around that lake. The only time special consideration or further detail would have to be supplied is if the land would be re-zoned to a Multi-lot residential then the rules of the Area Structure Plan would have to be applied as to size restrictions or regulations.

Reeve - Reply: Yes! It is allowable to sub-divide 1 – 10 acre parcels. The land classification now is zoned as Agricultural and would have to be re-zoned to Multi-lot Country residential or Conservation classification. This involves a public process and a public hearing will be held. Each case is dealt with on an individual basis.

General Public

Comment for Clarification:

- Previous developments – are they grandfathered in?

Reeve – Reply: There is no wording stating a Grandfather Clause – but current development stays the same until a change is requested.

Example: Outdoor outhouses currently in place currently stays the same until changed. When a new structure is to be built – then it is in accordance to new regulations.

General Public

For the Bylaw(s):

Comments for Clarification:

- The understanding is that there is room to develop Multi-lot Country Residential lots of condos or towns houses if they had their own water supply and sewer systems. So someone could come and develop and would allow a great density of people to live in a Cluster area that would not have a huge environmental impact on the area. Structure Plan indicates develop resources that would not have an impact the lake because the lake is at it maximum development. Is this something that Council would be looking at?

Reeve - Reply: People can apply for anything they want. Then it comes to the Municipal Planning Commission and conditions will adhere to in accordance with the Area Structure Plan, Land Use Bylaw, and the Municipal Development Plan. The rules provide options for Multi-lot Country Residential or Conservation which is what you are referring to where the piece of property will be 50% is reserve and they can have the density and have to provide water and sewer. This will then go through a process where a Public Hearing is held for the opportunity for the Public to speak for or against specific issues. It is difficult to explain because we do not know what the plan will be. But the Area Structure Plan rules would have to be adhered to.

Planning Manager - Reply: Right now there is no Area Structure Plan for Mons Lake and it is very difficult for the Municipal Planning Commission to be able to set strict standards or rules. The Area Structure Plan will be a very useful document to help guide the decision makers and what rules the applicants to live by.

Jane Dauphinee, Planner, Municipal Planning Services (Alberta) Ltd. entered the Council Chambers, time 9:25 a.m.

General Public

Comments for Clarification:

- It is frightening to read when a Multi-lot Country Residential lots clustered in a small area and how many people will be accessing the trails and the lake – and that this would even be considered.

Planning Manager - Reply: You were provided today copies of the proposed Area Structure Plan – but there is another larger background document, to difficult to make copies for everyone, that is support document which is available on the web-site which has the research to help support and identify the challenges the lake has.

Municipal Planning Services - Reply: The proposed Area Structure Plan has no land designated for Multi-lot Country Residential or for the Cluster Country Residential development in this plan at all. In terms of future development this doesn't designate area for future Multi-lot Country Residential – only indicates the Multi-lot Country Residential that are already built now. This is very restrictive plan for additional Multi-lot Country Residential development within the Mons Lake Area. Provided a brief overview of the environmental sensitivity of the area.

County – Reply: Proposed development within an area of land already re-districted is a Development Permit process which is advertised in the newspaper for comment or appeal. Land to be re-zoned or reclassified this is a Bylaw process – a much broader process that involves a public process and a public hearing to be held.

Planning Manager – Comment: Provided the process involved in for the sub-division application as per the County's Land Use Bylaw.

Municipal Planning Services - Comment: Indicated on the map the designated areas within Mons Lake Area.

The Reeve asked if any further issues or concerns and any further rebuttals for or against **Bylaw 1216-10: to develop and adopt a Mons Lake Area Structure Plan.**

Policy Statement No. 01-36-01: Expenses and Contributions to Political Functions

406-11: Bobocel

That **Policy Statement No. 01-36-01** entitled " Expenses and Contributions to Political Functions", be adopted:

Purpose:	To set clear and uniform parameters regarding political contributions and expenses for participation in political functions for the interaction with Federal and Provincial registered parties, constituency associations and candidates.
Policy Statement and Guidelines:	
<p>1. OBJECTIVE:</p> <p>1.1 Smoky Lake County recognizes that there is legislation that restricts the County from funding Political campaigns or contributing to political fundraisers.</p> <p>1.2 Smoky Lake County also recognizes that attendance by Councillors and senior Administration at Federal and Provincial political events and fundraisers is part of local government duties and benefits the County.</p> <p>1.3 Smoky Lake County will review and approve all requests for attendance of and support for political party or candidate – related events.</p>	

2. STATEMENTS:

- 2.1 The interaction with officials of various governments and political parties is to insure the promotion of Smoky Lake County's interests. It is customary business practice to maintain cordial, harmonious relations with official governments and political parties at various levels. Although the County encourages such relations, it is absolutely essential to comply with legislation and preserve the integrity and the appearance of integrity of both Smoky Lake County and its representatives as well as the officials of governments and political parties.
- 2.2 This policy is intended to provide guidance in determining what expenses incurred in attending Federal and Provincial political events will be costs reimbursed by the County and what are to be personal expenses that will not be reimbursed by the County.

3. RELEVANT LEGISLATION:

3.1 Federal Political Events:

The *Federal Elections Act*, as amended, provides that no person or entity other than an individual who is a citizen or permanent resident shall make a contribution to a registered party, a registered association, a candidate, a leadership contestant, or a nomination contestant.

A municipality, being a corporation, is an ineligible contributor and cannot make contributions. Accordingly, any tickets, registration fees or donations to any federal registered party, registered association, a candidate, a leadership contestant or a nomination contestant are personal expenses of a member of Council.

3.2 Provincial Political Events:

The *Provincial Election Finances and Contributions Disclosure Act*, as amended, provides that a municipality is a prohibited corporation and may not make any contributions to a registered party, registered constituency association or registered candidate.

A "contribution" means any money or real or personal property that is provided:

- 3.2.1 to a political party, constituency association or candidate, or
- 3.2.2 for the benefit of a political party, constituency association or candidate with it's or the candidate's consent,
- without compensation from that political party, constituency association or candidate.

4. PROCEDURES:

Smoky Lake County officials may attend political functions and be compensated for expenses incurred therefore in accordance with applicable legislation.

4.1 Business Meetings:

Meetings with the Prime Minister, MP's, Premier, Federal or Provincial Cabinet Ministers, or MLA's, call by or arranged by either the politician or the County, wherein governance matters relating to the County, either directly or indirectly, are discussed:

- 4.1.1 In such instances the costs of the meeting, hall rental, registrations, meals, etc. shall be treated as business expenses of the meeting and are reimbursable in accordance with County expenses protocol.

Example: Luncheon Meetings with Minister, MLA Breakfast, etc.

4.2 **Fundraisers:**

A “Fundraising Function” includes any social function held for the purpose of raising funds for a registered party, registered constituency association or registered candidate by whom or on whose behalf the function is held. Any contribution to a registered party, registered constituency association or registered candidate as determined below is a personal expense of a Councillor. Any amount deemed to be allowed for expenses as determined below may be reimbursed in accordance with County expenses protocol.

If an individual is charged by the sale of tickets or otherwise charged for attending a fundraising function held by or on behalf of a registered party, registered constituency association or registered candidate, then for the purpose of complying with legislation.

4.2.1 If the individual charge is \$50.00 or less, it shall not be considered as a contribution unless the person who pays the charge specifically requests that the charge be considered as a contribution, in which case one-half (½) of the amount shall be allowed for expenses and one-half (½) of the amount shall be considered as a contribution to the registered party, registered constituency association or registered candidate, as the case may be.

4.2.2 If the individual charge is more that \$50.00, \$25.00 shall be allowed for expenses and the balance shall be considered as a contribution to the registered party, registered constituency association or registered candidate, as the case may be.

Examples: Premier’s Dinner, Constituency Golf Tournaments, Constituency Bar-B-Q (not held for charity) etc.

4.3 The County shall not reimburse for annual membership fees for a political party or a constituency association of that party, or for a general collection of money solicited at a meeting held on behalf or in relation to the affairs or a registered candidate, registered party or registered constituency association.
