Chief Administrative Officer's Report

The Chief Administrative Officer gave an updated report to Council for the period of June 23, 2011 to July 26, 2011.

Legislative / Governance:

- Require meeting dates for Risk-Pro Committee for August and Policy Committee for August or September.
- Received a letter from Sid Mulkay requesting permission to fill two mud holes on one of our undeveloped road allowance and provide two culverts for him to install.

Administrative:

- Awarded the tender for the paving to Sandstar Construction Ltd..
- Have sent the engineering specs for office roof repair to five roofing contractors for quotes. Have only received one response to date.
- Attended a meeting and site tour of the Whitefish and Spedden Towers with Corridor and Industry Canada officials.
- All three Development Permits for the 3 Broadband towers have now been approved. Corridor Communications Inc. has assured me that the construction shall start in shortly (in August).
- The Agreement between the County and Corridor Communications Inc. is prepared from our end. Amir Bigloo and his staff are plugging in the latitudes/longitudes of the towers and adding the budget figures. Should be ready for signing by August 1, 2011.
- Have been corresponding with our Assessors and Municipal Affairs regarding the assessment and taxation of Internet Towers owned by Municipalities and/or sited on Municipal land.
- Amir Bigloo from Corridor Communications Inc. has indicated that after consulting and meeting with Corridor's new CFO, that Corridor Communications Inc. may require our services to set up their Internal minutes and filing system. He is willing to compensate the County either through cash or share capital. If so, this would only require 2-5 days of work and might be scheduled in August or September around the regular Corridor Board meeting(s).
- Sent three workers from Public Works Department to Slave Lake for the rebuild efforts there.

Human Resources:

Beginning the evaluation cycle for Management.

Community:

- Smoky Lake Riding Club has sent two sets of tickets to the Rodeo for Council to attend or allocate.
- Have confirmed with Alberta Environment that they have no problem with the shore cleanup or use of well water for rinsing. There seems to be no need at the moment for hauling sand, but if this "need" arises, it must be cleared with Alberta Environment as well. As for any future infrastructure upgrades, the Lions' Club has not yet responded to our request for drafting a proposal. This will hopefully be done by them before our new budget cycle in case there is any financial requests of the County.
- Assisted the Smoky Lake Agricultural Society with the blading of their parking lot and donated 100 Tonne of gravel. Also, took 60 Tonne of Gravel to the Vilna Arena to assist with the storage of fire units after the Fire at the Fire Hall.
- Have arranged for the fence to be built at the Doctor House.
- Received a letter from George and Catherine Brooks regarding the new sign at Sandy Lane Park.
