On-Farm Stewardship Program Update

- o Program opened April 2, 2013
- o As of May 16, 2013, 150 applications have been received so far (allocating 40% of the 2013 budget). So far the budget looks really good, if this pace continues
- No mass floods of applications once the program was opened

Environmental Farm Plan Update

- Environmental Farm Plan administration is in the process of being passed along to the ARECA groups (Agricultural Research and Extension Council of Alberta) from the Agriculture and Rural Development
- This process has been started since early March, a coordinator position has been advertised but still no one knows the status of the program, whether to use new of old procedures or who the new coordinator is
- Working with the Community Learning Council to plan the 2014 Ag Workshop & Tradeshow
 - Date scheduled for March 11, 2014 in Smoky Lake
 - Lots of focus going to be placed on the Ag Industry Tradeshow
 - O Have succession planning speaker confirmed, looking for a speaker that can talk about Ag/Farm business planning
 - o Will be sending out letter inviting industry representatives to participate in the tradeshow beginning of July
- Meeting with Thorhild County to discuss possible continued partnership for the 2014-2017 Environmental Program Stream
 - o Meeting held May 7, 2013
 - 2014-2017 Program planning surveys mailed to all farm boxes in Smoky Lake and Thorhild Counties (920 boxes in total) on May 17, 2013
 - o Only 4 surveys returned (questions below)
- Grazing School for Women
 - o Planning prior to event; updating social media sites, sponsorship acknowledgement, binder packages, etc.
 - o Event held on June 12 & 13, 2013 near Vermilion
 - o Had ~25 participants on each day
 - O Participants seemed to enjoy the ½ day farm tour and full day sessions
 - O Very well received, lots of positive feedback
