Purpose: This program is set out to replace fence posts along road allowances which have been damaged due to winter snow plowing for adjacent landowners.					
Policy Statement and Guidelines:					
1. STATEMENT:					
This is a Policy of the Smoky Lake County to replace fence posts which were damaged or broken for adjacent landowners along road allowances related to the County's Winter Snow Benching Process during the Winter Snow Plowing Season.					

2. GUIDELINES:

- 2.1 In order to be eligible to receive replacement fence posts, a serviceable fence must be in existence and be in a state of good repair located on the property boundary or within the landowner's property. The condition of the current posts must not reflect visible rot or instability.
- 2.2 The condition of the fence and eligibility to receive replacement posts will be determined by the Public Works Manager and the Public Works Foreman after communicating with the affected landowner, and prior to providing replacement posts.
- 2.3 Smoky Lake County will provide fence posts to the eligible landowner for the replacement of damaged or broken fence posts.
- 2.4 The landowner will be responsible for the fence post installation and will be compensated by the County five dollars (\$5.00) per post for installation.

3. PROCEDURES:

- 3.1 The affected landowner is to notify the Public Works Department to report broken fence posts.
- 3.2 Upon inspection, and once approved by the Public Works Manager and/or the Public Works Foreman, fence posts will be provided to the landowner to replace any existing broken posts.




