Legislation Reference:	Alberta Agricultural Pest Act of Alberta				
Purpose:	Smoky Lake County recognizes there are circumstances where the Agricultural Service Board Staff may need to use a Firearm in the course of their duties to control Beaver or Muskrat in rights-of-way or lands affecting County infrastructure. The purpose of this policy and procedures is to provide a process for authorizing individual(s) to possess, discharge, and store firearms on property owned and operated by the Smoky Lake County.				
Policy Statement and Gu	idelines:				



- muskrat, coyote, and skunk, and occasionally cougars. There are rules, regulations and common sense guidelines to consider when dealing with controlling problem wildlife, whether they are living on County property or in the wild.
- 1.2 The Agricultural Service Board Strategic Plan, as reference in Policy Statement 62-10: Agricultural Services Board Strategic Plan outlines management control activities for Problem Wildlife and Pest Control to ensure County residents that agricultural programming is maintained and in compliance with applicable regulations to enhance the environment and protect viable and sustainable agriculture (land and public roads) in the Municipality.
- 1.3 The use of Firearms is permissible in Wildlife Habitats as identified with the Discharge of Firearms Legislation. Use of Firearms is one part of multiple control techniques to control problem wildlife.

2. GUIDELINES:

- 2.1 The issuance of authorization to permit employees of the Smoky Lake County Agricultural Service Board to carry and use firearms for the control of problem wildlife while conducting field work in County locations in the performance of their official duties will be granted by the Chief Administrative Officer for the permission for possession, discharge or storage of firearms on property owned or managed by the County and approved by motion of Council.
- 2.2 Failure by any individual to comply with this policy or additional provisions of Federal, Provincial Legislation and Municipal Bylaws and Policies or handling a firearm in an unsafe manner will result in an immediate withdrawal of authorization to store, possess, or discharge a firearm on County property.
- 2.3 The Agriculture Service Board will implement the Discharge of Firearms for control of Problem Wildlife limited only for:
 - 2.3.1 Beavers and Muskrats only
 - 2.3.2 Problem Wildlife specified on the holder of a Form 7 issued by The Government of Alberta

3. **DEFINITION(S)**:

3.1 Firearm: Any device capable of discharging a center or rim fire cartridge, black powder, CO2-powered projectiles, or projectiles powered by pumping or cocking the device.

4. PROCEDURES:

- 4.1 Personally-owned firearms used for County business:
 - 4.1.1 A description of the firearm (restricted to .22 or .22 magnum caliber rifle) shall be provided by the individual and the information shall be completed on the **Schedule "A": Firearm Authorization Form.**
 - 4.1.2 The individual must supply a copy of their Firearm License (PAL) Possession Acquisition License to be placed in their personnel file, to verify the individual can legally possess, transport, handle and discharge a firearm.
 - 4.1.3 Personally-owned firearm(s) must be removed from the County property and Vehicles at the end of each work day.
 - 4.1.4 When not being used by the authorized employee in the process of performing his/her official duties during working hours, the personally-owned firearm shall be maintained unloaded and in a locked location approved by the Agricultural Fieldman. Ammunition for the firearm shall be maintained in locked location separate from the firearm.
 - 4.1.5 Personally-owned firearm(s) must be properly secured and stored at all times with the appropriate firearms transportation implemented in the municipal vehicle as per the Firearms Act and Regulation thereto.
- 4.2 Nothing in this policy requires Smoky Lake County to provide storage facilities for employee's firearms.
- 4.3 The authorized employee must carry the approved permits in their possession at all times when controlling beaver or muskrat within the right-of-way for examination by RCMP and Fish and Wildlife Officers. Documentation required:
 - Damage Control License
 - · Possession Acquisition License
 - Possession Only License
 - Signed Schedule A Form
