Three Year Capital Budget

The Finance Manager presented the Three Year Capital Budget that identified the capital projects proposed for 2017, 2018 and 2019. The plan includes budgets for transfers to reserves for future purchases (\$130, 000), new projects (\$1,738,648) and capital replacement (\$1,580,500).

Projects included in the capital budget other than replacement are:

- 1. \$26,500 has been added to complete the highway signs (this was removed in 2016).
- 2. \$17,000 budget to replace the gates at the Public Works Shop with automatic gates. This was budgeted in 2016 and is funded from reserves.
- 3. \$10,000 has been budgeted for the initial purchase of a drone. The drone will be used across all departments to view areas of concern. Sensors for the gas system etc. will be added in future years.
- 4. Aerial photos have been added to the budget for 2017. The budget is \$86,000
- 5. \$5,000 has been budgeted to build a plastic jug containment area at the Bellis Transfer Site.
- 6. \$7,000 has been budgeted for the Recreation Lease Renewal at Kaduk Lake
- 7. Mons Lake Association has received grant approval for a playground. We will spend \$50,000 for the playground and they will pay approx. \$25,000.
- 8. The Gas system includes \$200,000 (funded from reserves) to establish a new gas source as well as \$65,000 to upgrade the Odorant.
- 9. AMR implementation is an ongoing project being funded from reserves.
- 10. Bear Proof Garbage Bins is another ongoing project. We will install \$11,000 per year until all of the lakes are complete.
- 11. Carry over of the Warspite and Spedden Water Reservoirs are covered through reserves and grants.

Property Tax Rate Options

Finance Manager, Brenda Adamson, presented the 2017 tax and mill rate information, including:

- Assessment decreases of 1% for Residential, 9% for Non-Residential and 2% decrease for Machinery & Equipment.
- The Three Year Financial Plan predicted a need for a 10% increase in tax revenue for 2017, and we have brought the actual needed tax revenue increase down to 2%.
- Linear Assessment continues to decrease.
- Although the requisitions changed very little, the decrease in assessment creates the need to increase the rate.
