### 2017 Three-Year Road Plan

Discussion

The Three Year Road Plan identifies and prioritizes the roadway improvements required. The three year road plan was approved on October 20, 2016. The following changes have been made so far:

County Council Motion 585-17: That Smoky Lake County amend the 2017 Three-Year Road Plan to adjust the 2017 Gravelling Project Budget of \$800,932.00, by an increase in the amount of \$994,418.00, for a Total 2017 Gravelling Project Budget in the amount of \$1,795,350.00, for the purpose of additional road gravelling throughout all divisions due to above average moister last fall, and poor road conditions this spring; and that funds for the

adjustment be allocated from: the Operating Reserve in the amount of \$500,000.00, the Gravel Contingency Budget in the amount of \$163,134.00, and the Operations Budget for the remainder.

County Council Motion 661-17: That Smoky Lake County amend the 2017 Three-Year Road Plan - "Oil Treatment / Paving" Project P1713: Township Road 584 between Highway 855 and Range Road 175 by deferring the said project to the 2018 Three Year Road Plan; therefore decreasing the 2017 "Oil Treatment / Paving" amount from the total amount of \$155,000.00 to a zero amount.

667-17: Smigerowsky

That Smoky Lake County amend the 2017 Three-Year Road Plan by deferring the following 2017 Road Projects: C1612, C1622, C1715 and C1725 to the 2018 Three-Year Road Plan; and adding project: C1735: Construction of Township Road 604 between Range Road 181A and Range Road 182 at a budgeted cost of \$80,000.00.

## 5. <u>Issues For Information:</u>

#### **Property Tax Rate Options**

Finance Manager, Brenda Adamson, presented information for setting the 2017 Property Tax Rate, and spoke to the following points:

- There would be a shortfall in the 2017 Budget if the 2016 Property Tax Rate is used due to the changes in Property Assessment.
- The Three Year Financial Plan predicted a need for a 10% increase in tax revenue for 2017.
- Deletions of capital projects as well as fine tuning the operations budget has decreased the municipal tax revenue required by \$400,000 as of May 3, 2017.
- Property Assessment has decreased so the Property Tax Rate needs to increase to compensate.
- Requisition amounts form the Foundation and School Boards have changed very little from 2016, however, Smoky Lake County's decrease in Property Assessment forces the need to increase the requisitions tax rates.
