7. Delegation:

Agriculture Financial Services Corporation (AFSC)

Present before Council from 9:29 a.m. to 9:55 a.m. was Yvonne Weinmeier, Production Specialist – Insurance, Agriculture Financial Services Corporation (AFSC) to provide information on Unseeded Acres including the following points:

- There was a significant amount of unseeded acres in fall 2016 at an unprecedented magnitude.
- Insurance benefits are based on total production for the year.
- Unharvested advance partial payments were distributed in fall 2016.
- Turned out better than anticipated, there were only a handful of clients that were not able to get their 2016 crops off.
- Spring 2017 resulted in excess moisture.
- The insurance adjustors are currently inspecting to come up with a number for unseeded acres.
- There has been one non-compliance of advance payment payback.
- For the past 17 years the unseeded acre payout has been \$42, and this year it is \$47 or \$108 if previously fertilized.
- In Alberta there is one million acres claimed as unharvested and of that, 500,000 acres are in central Alberta.
- Crop insurance claims so far are as follows: Athabasca area 59, Smoky Lake area 34, St. Paul area 95, and Thorhild area is 69.
- In 2009 the insurance coverage went to individual, from township previously; it is almost impossible for every field to be inspected.
- Policy changes for unseeded acres now include a percentage of quality grade, and producers can now sell to unregistered buyers.
