National Airlines Council of Canada

That Smoky Lake County, in response to the email correspondence received from Massimo Bergamini, President and CEO of National Airlines Council of Canada, dated August 31, 2017, support the resolution of the National Airlines Council of Canada: Whereas in a country as vast and sparsely populated as Canada, safe and efficient air transportation is essential to connecting families and communities and to continued economic prosperity; Whereas Canada's airports are vital assets that contribute to the quality of life and economic growth in the cities, communities and regions they serve; Whereas media reports indicate that the Government of Canada is actively considering selling Canada's airports to for-profit entities to achieve a one-time financial windfall; Whereas the international experience in airport privatization has often resulted in higher fees and reduced services for travellers and airlines as a result of efforts to maximize return on investment; Whereas such outcomes would negatively affect communities of all sizes across Canada by making air travel more expensive and reducing service;

Whereas the last decade has seen a massive increase in the number of Canadians using air travel to connect with loved ones, enjoy well deserved vacations and explore the country, or help create jobs; Whereas any increase in fees on air travel resulting from the privatization of airports would constitute an unfair tax on Canada's middle class; Whereas divestiture of airports to local not-for-profit authorities in 1994, led to massive user-financed investments in airport infrastructure which have given Canada an enviable network of world class airports; Whereas the physical infrastructure of airports has been modernized, the governance system under which they operate has not kept up with the times and is now in urgent need of repair; Whereas that situation would only be exacerbated in a privatized for-profit system; **Be** it resolved that Smoky Lake County calls on the Government of Canada to renounce its push for the for-profit privatization of Canada's airports and clear the way for needed improvements to the current airport governance and financing system; and Be it further resolved that Smoky Lake County urge the Federation of Canadian Municipalities (FCM) bring this matter forward for emergency debate at the next meeting of its National Board of Directors.

PUBLIC HEARING:

Bylaw No. 1306-17: Aggregate Extraction Business Licence

Reeve Craig Lukinuk called the Public Hearing to order at 9:21 a.m. in the presence of Council members, Chief Administrative Officer, Assistant Chief Administrative Officer, Finance Manager, GIS/Communication Director, Public Works Manager, Public Works Foreman, and Recording Secretary.

1.0 Opening

- 1.1 Reeve Craig Lukinuk declared the Public Hearing open at 9:21a.m., stated he will be the Chair of the Public Hearing, welcomed all persons in attendance, and outlined the hearing procedure as follows:
 - 1. The Council is here to listen to the information presented, and to make decision on the matter that is the subject of the hearing.
 - 2. This is a formal hearing and is not a debate. Everyone wishing to speak will be given an opportunity to speak once to the matter.
 - 3. All persons wishing to be heard at this public hearing should sign in on the sign in sheet (located on the table at the front of the Council Chambers) giving their name and address.
 - 4. The Chair shall call upon those individuals who have preregistered on the sign-in sheet giving their names will speak first.
 - 5. Persons who do not sign in shall speak only after all those who signed in have given their presentations. We ask that anyone who wishes to speak but has not yet signed in, please sign in now.
 - 6. An individual who does not identify himself or herself will not be given the opportunity to speak.

- 7. Public Hearing Presentations will proceed as follows:
 - 7.1 those speaking in support (in favour);
 - 7.2 those speaking opposed (against);
 - 7.3 follow up questions from Members;
 - 7.4 questions of the Administration from Members.
- 8. Councillors will be given the opportunity to ask questions,
- 9. Council will then end the Hearing and consider the information received at the public hearing,
- 10. Only Councillors may ask questions of speakers during the Hearing. If any persons wish to ask questions of a speaker, they must ask Council to ask the question on their behalf during their presentation, and Council will only ask the question if a Councillor wishes to have an answer.
- 1.2 The Reeve asked the Chief Administrative Officer to confirm that the Public Hearing had been advertised and notice had been provided in accordance with the applicable legislation.

 The Chief Administrative Officer replied: Yes it has Mr. Chair.

Bylaw No. 1306-17: a Bylaw of the municipality of Smoky Lake County in the province of Alberta to provide for Licensing of Aggregate Extraction Businesses operating within Smoky Lake County, has been advertised and notice has been provided in accordance with Section 606 of the *Municipal Government Act, R.S.A.* 2000, Specifically, Sec 606(2) which states:

Notice of the bylaw, resolution, meeting, public hearing or other thing must be:

- (a) published at least once a week for 2 consecutive weeks in at least one newspaper or other publication circulating in the area to which the proposed bylaw, resolution or other thing relates, or in which the meeting or hearing is to be held, **or**
- (b) mailed or delivered to every residence in the area to which the proposed bylaw, resolution or other thing relates, or in which the meeting or hearing is to be held.

On September 5, 2017, the current Smoky Lake County aggregate operators were emailed a copy of the Public Notice advertisement, as well as a copy of the proposed Bylaw, with a deadline of September 22, 2017, for the public to submit a written response.

Public Notice of the Public Hearing was advertised in the Smoky Lake Signal and Redwater Review for two weeks on September 11 and September 18, 2017.

2.0 Staff Presentation

 - The purpose of this Hearing is for the Council of Smoky Lake County to obtain **Public Input**, in favour and opposed to the Bylaw No. 1306-17: Aggregate Extraction Business Licence.
 - The purpose of the Bylaw No. 1306-17 is to establish rules of procedure to operate Gravel Crushing, Aggregate Hauling, Concrete Batching Plant, or Asphalt Batching Plant, businesses; and to establish a fee schedule based on the type of business, and the amount of productivity.

July 3, 2014, Council Motion No. 693-14: Administration was directed to research and explore options for implementing a Business License Bylaw.

July 24, 2017, Policy Committee Motion No. 104-17: The Policy Committee recommended Bylaw No. 1306-17 be forwarded to a County Council Meeting for First Reading.

August 17, 2017, Council Motion No. 941-17: Bylaw No. 1306-17: was given the FIRST READING; and a Public Hearing was scheduled for Monday, September 25, 2017 at 9:15 a.m. in County Council Chambers.

- Lisa Ball, President, CEO of JLG Ball Enterprises:
 - We've had a haul road agreement in the past, is this just to diversify?
 - Reply from Cory Ollikka, Chief Administrative Officer: If this bylaw passes it would repeal the haul road agreement that you currently operate under. The payment amounts are the same. The purpose of the bylaw is to assist administration with enforcing the levies. The Haul Road Agreement was under a policy and this new bylaw would replace the policy.
 - Do we have to apply for each individual activity?
 - Reply from Cory Ollikka, Chief Administrative Officer: No, you would just list them all under one application and pay one fee that is payable upon shipping.
 - Would the bylaw be applicable on private and crown land?
 - Reply from Cory Ollikka, Chief Administrative Officer: Yes.
 - The Information would be under the development permit?
 - O Reply from Cory Ollikka, Chief Administrative Officer: You would need to apply for this business license every year. It would be based on an estimation, it's an easier way to track the activity, if you are conservative in your estimations numbers when you apply, and at the end of the year it was more than estimated, you would pay for more or if the estimation is less, you would pay less.
- Johnny Cherniwchan, Smoky Lake County Resident:
 - The fee that you levied, as far as roads go, if there's enough, I think it is a good idea; if there is enough revenue to maintain those haul roads.
 - o Reply from Craig Lukinuk, Reeve: According to Administration, the fees are appropriate to cover the cost.
