

Purpose: Smoky Lake County will govern the municipal mowing program on developed road allowances and County lands under the Agricultural Service Board.

Policy Statement and Guidelines:

1. STATEMENT:

- 1.1 Smoky Lake County will mow developed road allowances annually to maintain safe visibility for the travelling public and to improve drainage of infrastructure.
- 1.2 The mowing program promotes effective control of weeds and brush within the municipal right-of-way encroaching the roads surface.
- 1.3 The County will mow County lands on a as needed basis.

2. DEFINITION(S):

- 2.1 County Lands: Property owned and/operated by Smoky Lake County
- 2.2 **Developed Road Allowances:** Road allowances containing a gravel or hard surfaced roadway under the jurisdiction of Smoky Lake County.

3. OBJECTIVES:

- 3.1 Define areas that will be moved within the right-of-way and on County lands.
- 3.2 Provide the level of right-of-way mowing as set out by the Agricultural Service Board.
- 3.3 The County's desire to achieve the following objectives with its roadside mowing program:
 - to assist with weed control by preventing the seed set of noxious weeds in the rightof-way and to cut any brush regrowth encroaching on the road
 - to enhance road maintenance with minimal gravel loss and allow positive drainage of rainwater to be more efficiently channeled to the right-of-way
 - to increase visibility of wildlife crossing and reduce obstructed visibility of signs at intersections for the safety of the travelling public
 - to provide a fire break and reduce the amount of fire load material in right-of-way.

4. GUIDELINES:

- 4.1 The mowing program will be developed and planned by the Agricultural Service Board and implemented through the Agricultural Services Department. The defined mowing areas consist of three (3) zones, divided using range road 150 and Highway 855 as boundaries.
- 4.2 Ditch clean-up and equipment maintenance will commence 2 weeks prior to mowing program start date.
- 4.3 One-pass herbicide mowers will begin mowing operation the first week of June for more effective weed control. Non-herbicide mower operations will begin the last week of June. All mowing operations will cease no later than November 1st.
- 4.4 Mowing Operations consist of three (3) tractors and mowers used to cut grass, brush, and noxious weeds. These mowers are able to accomplish a significant amount of mowing and right-of-way clearing very efficiently when compared to other methods of mechanical control.
- 4.5 Without limiting the program or its effectiveness, it will generally be planned as following:
 - 4.5.1 Developed Road Allowances: All grassy areas along, oiled, or gravel roads will be mowed once a year mowing from roads edge to property line where conditions allow. Which may require several mowing passes to accomplish.
 - These secondary passes should be a minimum of 5ft.
 - Main roads into lake resorts will only be mowed prior to the July and August long weekends (two seasonal passes per year)
 - Township Road 610 from Range Road 181 East to Hwy 855 will be mowed in conjunction with the lake resorts prior to July and August long weekends (two seasonal passes per year)
 - The Iron Horse Trail shall only be mowed once per season
 - It is recognized that inclement weather, such as rain and early winter could prevent completion of the program
- 4.6 All other mowing requests will be at the discretion of the Agricultural Service Board and added to **Schedule** "A" **Approved Additional Mowing**



2021 Bertha Armyworm Monitoring


It will be critical to have very good coverage of pheromone traps in 2021 to develop an early warning of potential problems during the coming season. This trend, however, indicates that a bertha armyworm outbreak is possible or even likely in Southern and Peace regions of Alberta.

Normally, weather and natural enemies keep bertha armyworm populations in check Parasitism rates of 50 to 60% in bertha larval populations have indicated the end of a local outbreak in the following year. In addition, as we saw in 2013, disease outbreaks can have a major impact on the bertha armyworm populations. Snow cover encourages successful overwintering, in contrast low snow cover with cold temperatures reduces winter survival. Monitoring, even in low flight years, allows us to pick up trends and better predict when bertha armyworm populations start to build-up and lead into new outbreaks.

Potential damage from bertha armyworm may be more or less severe than suggested by the moth count data depending on weather and crop conditions and localized population dynamics. An insecticide application is recommended when the larval numbers meet the <u>economic threshold</u>.


During the monitoring season, the reported trap counts are displayed on a Google map. The map allows the viewer to zoom in and click on the individual balloons. Clicking on a balloon will display the organization responsible for the trap location, municipality where the trap is located, and both the weekly and cumulative counts. All counts displayed are the average of the two traps at the site. (All counts displayed are the average between the two traps at a site). During the trapping period, the information is updated as the entries are made into the data collection website. The resolution is not so fine as to pinpoint the exact location of individual trap locations.

The objective of the monitoring is to increase the awareness of canola producers to the damage potential of bertha armyworm. Forecast maps DO NOT replace field scouting. No field should be treated for bertha armyworm without proper field scouting. Moth catches indicate the potential for damage but the actual populations must be assessed. Experience from previous outbreaks has shown us that adjacent fields or even different parts of the same field can have greatly different bertha armyworm numbers. Producers growing peas and faba bean also need to pay close attention to the bertha monitoring system as bertha armyworm has been known to feed on both those crops.






Re: Concerns for Open Pit Coal Mining in the Eastern Rocky Mountains

To Committee Members,

The MD of Ranchland Agricultural Service Board wishes to express its concerns regarding the proposed construction of open pit coal mines in the Eastern Rocky Mountains, including loss of water quality, rangelands, and livelihoods.

Water quality and contamination is a major concern of ours. Toxic biproducts of open pit mines leach into surrounding water supplies, impacting water quality for not only our residents but many in southern Alberta. Evidence of extensive municipal water contamination in areas surrounding Teck Corporation's Elk Valley mines can already be found in British Columbia. Establishing these open pit coal mines in the Eastern Rockies is sentencing our residents and numerous Albertans to irreversible water quality issues.

Another concern is loss of our rangelands. The areas planned for mining are home to countless native species, including species at risk such as bull and cutthroat trout, grizzly bears, bighorn sheep, and mountain goats. Native species are slow to recolonize disturbed areas and instead invasive species take over. Animals rarely return to inhabit an area that has changed so drastically from human influence. Constructing open pit mines means more loss of rangelands, habitats, and native organisms.

Many of our residents derive their livelihoods by grazing livestock on lands proposed for/impacted by coal mines. This area boasts some of the best quality grazing lands in the province. Our producers use them responsibly and have demonstrated decades of environmental stewardship. In addition, these lands are popular areas for recreation and tourism. Both residents and visitors alike would be devastated by the creation of open pit mines.

Just because establishing open pit coal mines is "not an unlawful decision" does not make it a good decision. These are some of the most environmentally sensitive areas of the province. Implementing these mines would cause permanent, irreversible damage to the environment and the livelihoods of our residents. Our concerns deserve to be heard.

Though there may be economic benefit to allowing these mines, the environmental and social costs are simply too high. On behalf of members of the Agricultural Service Board, the residents of our community, and citizens across Alberta, do not build open pit coal mines in the Eastern Rocky Mountains.

Dear Honorable Devin Dreeshen,

Thorhild County Council would like to echo the message initiated by County of Grande Prairie No. 1 in its letter dated May 14th, 2021 addressing the importance of Agricultural Service Boards and their work for agricultural producers within all Alberta municipalities. Today, Agricultural Service Boards serve both the province, and agricultural producers, by bearing the responsibilities for the administration of the *Weed Act*, the *Pest Act* and the *Soil Conservation Act* of Alberta. Agricultural Service Boards are very active throughout the year. They participate in weed, pest and disease survey each year, provide assistance to Alberta Agriculture and Forestry staff, provide support to the *Line Fence Act*, the provincial veterinarian in case of a livestock disease outbreak and various other things.

Over the past decade, provincial funding for Agricultural Service Boards has been stagnant at a maximum of \$150,000 per year, with an additional \$18,000 made available at certain times. In 2020, this funding was reduced to \$123,907 per year for the next five years, while the activities required to maintain funding eligibility were not reduced. This reduction in funding comes while more provincial tasks are being downloaded to municipalities. With the loss of 'Ropin' the Web', the virtual impossibility of locating the wealth of information formerly contained on that site, as well as the changes made to the 310-FARM telephone line, more and more questions are coming into our agriculture departments to locate information. The loss of research and specialized staff means resource people, formerly available to answer questions are no longer available to assist residents and producers. Producer groups can be an excellent source, but they may not be as fully well-versed as a subject matter expert with broader base knowledge to draw from.

While the funding received from the province is greatly appreciated, it in no way begins to cover the costs of inspections and activities we are required to do to maintain eligibility for our annual grant. We appreciate that Alberta has spent more on agricultural services than other provinces in the past. Perhaps that is what allowed us to become world leaders in agricultural production, research, and development. To compare other provinces to Alberta agriculturally, and reduce funding accordingly does our province a great disservice. For our province to remain competitive and continue to grow this powerful sector, we need the support of the province.

Thorhild County understands the challenging financial times in which we are operating. We draw your attention to the fact that agriculture is the backbone of our province. Reducing support to the vital economic driver Albertans rely on, is counterproductive to maintaining a viable and thriving industry. By putting increased pressure on municipalities to deliver more with less, you compromise our ability to properly support our agricultural producers and through them the provincial economy.

Thorhild County Council requests that your government reinstitute recent cuts supporting the important work the province has tasked municipalities through the operation of all Agricultural Service Boards.

RE: Synthetic Fertilizer Emissions

Brazeau County's Agricultural Service Board (ASB) would like to express their concern regarding the Federal Government's emissions target for synthetic fertilizer.

While we recognize the importance of the reduction of synthetic fertilizer emissions, we support Fertilizer Canada's concern on how the reduction is measured and achieved.

There is currently a focus on increasing Canadian agricultural exports and increasing production of crops used for bio fuels. In order to achieve this production increase, a proportionate increase in fertilizer is also required. A reduction of synthetic fertilizer emissions essentially places a cap on overall synthetic fertilizer use. In essence, this will limit the production of crops.

Fertilizer Canada is suggesting that rather than a straight 30% reduction of total emissions allowable from fertilizer, a reduction in emission intensity or a measurement based on bushels produced may be more appropriate.

We strongly encourage you to continue to review how best to achieve the fertilizer emissions target without placing limits on overall crop production. Please do not hesitate to contact me if you have any questions or concerns.

Dear Smoky Lake County:

This letter is in reference to our Agreement for the Implementation of Wild Boar Containment Standards under the *Agricultural Pests Act* (APA) made effective on February 7, 2019 and expires on December 23, 2023.

As per Section 6 of this Agreement, our Minister shall submit a written status report to the county or municipality annually, for the proceeding twelve month period ending June 30, during the term of this Agreement to the date of the termination indicating activities undertaken by the Minister pursuant to the responsibilities of the Minister under this Agreement.

As you are aware, our Inspection and Investigation staff have been working closely with your Agricultural Fieldmen in an attempt to locate and identify any wild boar producers within your county. The administration of the *Agricultural Pests Act* is a combined responsibility of the province and counties/municipalities required under Section 6 of the *Agricultural Pests Act* (duty of local authority to take active measures to prevent the establishment of pests).

The risks associated with wild boar escaping containment and establishing a new "at-large" population are considerable. In order to manage these risks, inspections of wild boar production farms will be conducted at least once per year, or more if there are any compliance issues. Our inspectors will contact your Agricultural Fieldman in order to plan for joint inspections.

Agriculture and Forestry will continue with active wild boar at-large eradication that involves surveillance, trapping and euthanizing wild boars in order to eliminate the at-large population. If there is a report of wild boar at-large in your county, please call 310-FARM (3276) so we may work together towards a solution. Wild boar reports can also be sent to AF.WildBoar@gov.ab.ca. More information about wild boar in Alberta can be found here: https://www.alberta.ca/wild-boar-in-alberta.aspx.

To date, our Inspection Unit in conjunction with your Agricultural Fieldman have identified one a wild boar farm in Smoky Lake County. On November 27, 2019 the producer advised he has no animals at his farm, and has left the industry. Please advise if you hear of anyone else who might be in possession of wild boar in your county.

Honourable Minister Wilkinson;

The M.D. of Smoky River wishes to echo the concerns raised by Brazeau County in their June 16th letter.

The M.D. of Smoky River is a rural municipality renown for both its cropping and apiculture industries. Our producers count on synthetic fertilizers and innovative technologies to raise crops, and our beekeepers count on the healthy crops being grown (primarily canola) for honey production and to ensure their bees are healthy enough to survive our winter.

Canada has an opportunity to increase its agricultural production for exports (increasing GDP), to feed our population and also for use in green energy via biofuels. The proper utilization of synthetic fertilizers can be improved, and Government supported research, development and public acceptance of improved crop production via GMO & CRISPR technologies will also play a part. The technology can bring producers Nitrogen Use Efficient (NUE) crops and introduce Nitrogen Fixation into crops which are not naturally able to do so, like wheat and corn.

Our Canadian Agricultural Industry can achieve the emissions reductions, but only by embracing innovation. The industry must not be hobbled with a simplistic "let's cut fertilizer emissions by cutting use" approach.

As stated in the Brazeau County letter: "We strongly encourage you to continue to review how best to achieve the fertilizer emissions target without placing limits on overall crop production."
