2019 Budget Guidelines

Policy Statement No. 08-11-01: Budget Development, provides the guidelines for the budget process. The first step in budget creation is to get an understanding of Council's expectations for 2019 and future years. Items that need to be discussed are:

- Cost of Living increase for salaries
- ◆ The policies that council would like reviewed with budget implications.
 - Snow Clearing Policy
 - Mowing Program Policy 62-28
 - Dust Control
 - Sale of Sand and Gravel
 - Council Remuneration
 - Spraying
 - Other
- The percent increase (or decrease) in function or capital expenditures that are acceptable
- The priorities in the three-year road plan
- ✤ The Municipal Tax Rate

These guidelines along with the Strategic Plan and meetings, will be used to compile the Three-Year Road Plan, Capital Budget, and Operating Budget, and the Five-Year Financial Plan.
