
Brenda Adamson, Finance Manager provided an updated Financial report for the period August 22, 2018 to September 18, 2018.

7. <u>Delegation:</u>

Land Owner: Brian Henker

Present before County Council from 10:12 a.m. to 10:25 a.m. was Land Owner: Brian Henker to present information on the negative impacts resulting from water runoff onto the lands legally described as NW-33-58-19-W4 from the portion of Range Road 193A commonly known as Elsie Hill Road, that included the following points:

- Elsie Hill Road was reconstructed in 2014 with ditches made of soft clay and sand with nothing to keep it from eroding.
- Prior to the reconstruction, water used to run down the east side of the ditch through a culvert halfway down the road to the creek on the west side of the road as shown in light blue in figure #1 below.
- After construction the water now runs straight down the east side of the road to Victoria Trail and along the trail to my property and then pools and continues to overflow to the neighbors.
- The water has washed approximately 1,087 square meters of sand and clay (as shown in Figure #1, Area 1) and 7643 square meters of sand and clay (as shown in Figure #1, Area 2) onto private land.
- The "ask" is for the County to remove the sand and clay on his property and provide compensation for time spent and crop loss.

 - Farm Succession Planning with Elaine Froese March 15th, 2018 at the Smoky Lake Agri-Plex 44 attendees
 - Agriculture Funding Opportunities June 28th, 2018 at the Smoky Lake County Office 8 attendees
 - Smoky Lake Summer Field Day August 7th, 2018 at our research site on Highway 28 11 attendees
- Ron Bobocel is the LARA Representative for the Agricultural Research & Extension Council Association (ARECA)

- There are 12 research associations collectively doing applied research.
- Would like to involve Lakeland College to partner and get the education component related to public research that is unbiased and objective.
- We ask the County to consider the \$55,000 contribution to LARA because that funding then turns into a \$600,000 budget for LARA to provide research for the region which turns into \$1.5 Million from the province and is shared by all 12 associations.
- This is a very important aspect of agricultural industry, if Smoky Lake County ceases to be a partner, it takes away the opportunity to sit at the table and advocate and reduces regional cooperation and collaboration.
- The membership fees for Agricultural Research & Extension Council Association (ARECA) were increased on September 19, 2018 from \$3,000.00 to \$4,500.00 for each member.
- Several years ago, the province took away the District Agriculturalists, and it cut off the scientific link from the researchers to the farmers.
- Farmers have recognized that they need practical results that are scientifically determined.
- Our region is unique, the agricultural climate is different, so the local research is different and important, especially in young farmers. Kids in some cases don't grow up on the farm so they don't understand the basics, so when they are provided the scientific research to fall back on, it helps them with farming going forward.
- Let's be part of something that will be fruitful for generations to come.
- We are working with other municipalities trying to get them to buy memberships.
