TAX INSTALLMENT PAYMENT PLAN

The Tax Installment Payment Plan (TIPP) is an efficient program which allows you to pay your property taxes on a monthly basis instead of one annual payment.

Pre-authorized debits in the amount of the previous years taxes divided into 12 monthly installments, are paid each month beginning in January. In June, the monthly payment will be adjusted to reflect the actual taxes owing for that year.

Smoky Lake County must receive the Pre-Authorized Debit Form for Property Taxation Monthly Payment Plan no later than **NOVEMBER 15, 2024**.
